

## RECONSTITUTION OF BOARD AND BOARD COMMITTEES

The Board of Directors (the “**Board**”) of Aedge Group Limited (the “**Company**”), wishes to announce the following changes to the Board and the respective Board Committees of the Company.

### **Appointment of Director**
